For use in Class III Fresh/ Seawater, Fire Main, Water Spray, Foam, Sprinkler, Sanitary, Fuel/ Lube/ Hydraulic Oil, Gas and Air Piping Systems.

Description:

Specially shaped pipe fitting system with integral O-ring seals. Fittings and pipes of CuNi10Fe1.6Mn (2.1972.11 acc. to DIN 86019 and BWB material specification WL2.1972). O-rings of NBR, FPM, CIIR (depending on relevant working temperature and media). Fittings are pressed (crimped) in place by means of specially dedicated pressing tools.

Service Restrictions:

Unit Certification is not required for this product. Not to be used in potable water systems and for flammable fluids with flash points below 60°C.

Comments:

Each particular application, including deck/ bulkhead penetrations, of the press fitting system is to be specifically approved in connection with the relevant system and installation. Use of the fittings only in connection with "mapress" special pressing tools in accordance with manufacturer's instructions. Further, the manufacturer's instructions regarding compatibility of pipe/ fitting/ sealing ring materials and working media are to be followed.


